Stamped by registered engineer in the state of Washington.
Two (2) final hydrology reports, if applicable.
Other supporting documentations, if applicable. For example, sewer line analysis, pump station analysis, water line analysis, etc.
Estimated public improvement costs (if applicable). Cost must be laid out to include item name, quantity, unit of measurement, unit cost, extended cost, section totals, grand total, and include any applicable sales tax.
